- Employment background (dates from to, employer's name and contacts, type of company or sector, position in the company, main responsibilities, any relevant job experience specifically related to the field of planned startup, number of previously founded startups, short descriptions, any additional relevant experience,
- References (names, surnames, companies, institutions, projects, positions, contact phone numbers, email addresses)
- Information about the startup you plan to establish in the republic of Lithuania (short description of a business, period of operation, represented sector, stage of product development, company turnover in the past 12 months, other relevant financial information, information if the startup owns any industrial property within Lithuania, information if the startup has submitted any application in relation to the protection of

industrial property rights within Lithuania, information about target customers, information about main competitors, information about the potential market size, description of the business idea and how it is meant to be developed, description of why the business is innovative and significant for economic and social growth in Lithuania, description of established links with the startup ecosystem in Lithuania prior to the date of submission of the application, one – year action plan with key performance indices and two – year strategy, main goals, product development plan, main performance indicators, financial resources needed to achieve first-year goals.

We also collect information that will allow you to establish a username and password if you would like to do that. In addition, we collect all the information you choose to submit as part of your application for a Startup Visa in the Republic of Lithuania.

In addition, the Website may collect certain information automatically, including, without limitation, the type of device you use, unique device ID and your operating system and version, the type of browsers you use, preferred language and information about the way you use the Website (for how long and which pages you visit), your location (if you allow to disclose it).
